JOB SUMMARY:

The Head Coach is responsible for assisting each participant to achieve a high level of skill, an appreciation for the values of discipline and sportsmanship, and an increased level of self-esteem.

ESSENTIAL DUTIES AND RESPONSIBILITIES: Other duties may be assigned

- Coach individual participants in the skills necessary for achievement in the activity.
- Coordinates all aspects of the activity such as, but not limited to, practices and games.
- Assumes responsibility for the regulations under MSHSAA and Title IX.
- Maintain responsibility for maintenance and proper utilization of facilities.
- Ability to promote and maintain strong parental and community involvement.
- Assists in selecting, assigning, and evaluating all activity personnel for the activity.
- Ability to prepare an activity budget.
- Establishes the performance criteria for participation in an interscholastic activity.
- Recommends purchase of equipment, supplies, and uniforms.
- Maintains appropriate and accurate records for each activity.
- Responsibility for the safety, conduct, and general welfare of students.
- Maintains high standards of student conduct.
- Inventories and maintains equipment.
- Prepare appropriate reports as required by the District and the State.
- Represents the District on the appropriate committees.
- Maintains confidentiality, unquestionable integrity.
