#### JOB SUMMARY:

The Lead School Nurse will give leadership and guidance in the development and maintenance of the district nurses role in health services. The Lead Nurse will be available for consultation with the nurses and principals and orient them in the expectations of health services.

#### ESSENTIAL RESPONSIBILITIES AND DUTIES: Additional duties may be assigned

- Carries out the duties of a school nurse.
- Acts as a liaison to the Assistant Superintendent of Special Services and the nursing staff.
- Works with Assistant Superintendent of Special Services to plan for and facilitate meetings and professional development.
- Facilitate ordering of health clinic supplies.
- Assists in the preparation of district, state, and federal reports.
- May assist in the selection of nursing personnel.
- May assist in filling absences for nurses and health clerks.
- Works with district technology personnel to maintain and update the student health data base.
- Responsible for maintaining an up-to-date Comprehensive Student Health Manual for the district.
- Assists in the coordination of district nurses and district health advisory/wellness committee.
