JOB SUMMARY:

This position helps to maintain the physical school plant in a condition of operating excellence so that full educational use of it may be made at all times.

ESSENTIAL DUTIES AND RESPONSIBILITIES: Additional duties may be assigned.

- Maintains regular attendance.
- Ability to perform Carpentry, Cabinetry, Drywall Taping, and Finish Carpentry
- Assumes the primary responsibility for the safe condition of facilities owned and operated by the district.
- Accurately orders and accounts for material and labor relative to assignments.
- Maintains all safety and code requirements of the State, Local, and Board of Education.
- Assumes responsibility for determining which repair jobs may be performed by custodian, general maintenance, or outside contractor.
- Recommends supplies and equipment for purchase, and maintains the inventory of district-owned tools, equipment, and supplies.
- Performs preventative maintenance of district owned facilities.
- Attends/Completes District PD and training.
