#### **JOB SUMMARY:**

This position helps to maintain the physical school plant in a condition of operating excellence so that full educational use of it may be made at all times.

#### **ESSENTIAL DUTIES AND RESPONSIBILITIES: Additional duties may be assigned.**

- Maintains regular attendance.
- Proper handling of all products and materials to prevent damage or waste.
- Paint interior and exterior walls, ceilings, doors, cabinets, shelving, HVAC units, window frames, soffits, guttering, down spouts, and playground equipment.
- Seal and stain new doors and other woodwork.
- Patch walls, ceilings, metal doors and frames, tape new drywall and patches.
- Assumes the responsibility for the safe condition of facilities owned and operated by the district.
- Accurately orders and accounts for material and labor relative to assignments.
- Maintains all safety and code requirements of the State, Local, and Board of Education.
- Recommends supplies and equipment for purchase, and maintains the inventory of district-owned tools, equipment, and supplies.
- Performs preventative maintenance of district owned facilities.
- Attends/Completes District PD and training.
