In August 2018, the District will open a state-of-the-art early childhood center that will be able to serve 320+ students. It was important to the District to have a school that would complement and enrich the amazing learning experiences that occur in our preschool classes. Located at 1301 Boone's Lick Road, our 50,000 s.f. building will house 16 classrooms which are designed to be flexible space that will meet the need of our students as our program continues to grow.

The "flagship" of our building will be a one-of-a-kind, indoor gross motor and dramatic play room customized to be a miniature version of the shops of Main Street where students could play restaurant keeper, fire chief, medical professional, mayor, trolley conductor, or whatever else they choose.




